Online-only journal, not indexed in PubMed. Use the full journal name and doi (digital object identifier) or the web address (URL); both are not necessary. This type of publication can instead be listed under a subsection entitled "Electronic Publications" if it is NOT peer-reviewed.

ISBN identifiers can be noted for books and book chapters, to help CV readers quickly locate them. If available online as full-text, a URL is also helpful; only one identifier is necessary.

Chapter titles are <u>not</u> capitalized. Book titles <u>are</u>
